

TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India. for the work under Tender cost of **RS. 18,97,912/- (Rs. EIGHTEEN LAKHS NINETY SEVEN THOUSAND NINE HUNDRED TWELVE) ONLY**

2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website: www.asiagraticircle.in and e-portal eprocure.gov.in from **14/02/2023 to 25/02/2023**.

2 (a) The site of the work is available, or the site for the work shall be made available by the department.

2. The time allowed for the work will be **60 days** which will be reckoned after fifteen days from the date of issue of order to commence work.

3. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.

4. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of CPWD form No 7 and the total amount tendered in the case of CPWD form No 8 and should also be written in the same language.
