TERMS AND CONDITION FOR SUBMISSION OF TENDER

1. Tenders are hereby invited on behalf of the President of India, for the work under Tender cost of **RS. 14,51,380/- (Rs. FORTEEN LAKHS FIFTY ONE THOUSAND THREE HUNDRED EIGHTY ONLY)**

2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- www.asiagraticircle.in and e portal eprocure.gov.in from **16/12/2022 to 22/12/2022**.

3. (a) The site of the work is available, or the site for the work shall be made available by the department.

1. The Contractors should upload their tender documents online only at CPPP website: <https://eprocure.gov.in/eprocure/app> upto **15:00 hours of 22/12/2022** which will be opened on dated **23/12/2022 at 15:30 hours**.
