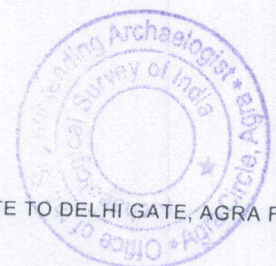

1. Tenders are hereby invited on behalf of the President of India. For the work under Tender cost of **RS. 19,14,970/- (Rs. NINETEEN LAKHS FOURTEEN THOUSAND NINE HUNDRED SEVENTY ONLY)**
2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- www.asiagracycircle.in and e-portal eprocure.gov.in from **21/09/2023 to 12/10/2023**.

4. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of CPWD form No 7 and the total amount tendered in the case of CPWD form No 8 and should also be written in the same language. In a case of illiterate contractors the rates or the amounts tendered should be attested by a witness.

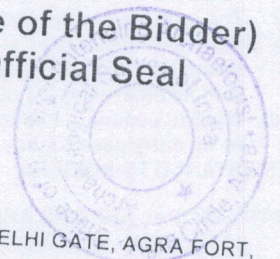
