- 4- The bidders are requested to visit the site and examine the requirement and its rate accordingly before quoting the rate in Online BOQ. If the Quoted rate is obvious vague (Extremely High or Extremely Low) the Same will not be considered and will be rejected at Financial Stage.

TERMS AND CONDITION FOR SUBMISSION OF TENDER

- 1. Tenders are hereby invited on behalf of the President of India. for the work under Tender cost of RS. 56,93,919/- (Rs. FIFTY SIX LAKHS NINETY THREE THOUSAND NINE HUNDRED NINETEEN ONLY)
- 2. Tender document consisting of the detailed plans, complete specifications, the schedule of quantities of the various items of work to be done, and the set of conditions of contract to be complied with by the person whose tenders may be accepted. The tender forms can be downloaded from our website- www.asiagracircle.in and e-portal eprocure.gov.in from 05/03/2025 to 26/03/2025.
- 2 (a) The site of the work is available, or the site for the work shall be made available by the department.
- 1. The Contractors should upload their tender documents online only at CPPP website: https://eprocure.gov.in/eprocure/app. upto 15:00 hours of 26/03/2025which will be opened on dated 27/03/2025at 15:30 hours.
- The time allowed for the work will be 210 days which will be reckoned after fifteen days from the date of issue of order to commence work.
- 3. The contractors should quote in figures as well as in words the rate and amount tendered by them. The amount for each item should be worked out and the requisite totals given.
- 4. When the contractors signs a tender in an Indian Language the percentage above or below and the tendered amount in case of CPWD form No.7 and the total amount tender in the case of CPWD form No.7 and total amount tendered in the case of CPWD form No.8 and should also be written in the same language. In a case of illiterate contractors the rates or the amounts tendered should by attested by a witness.

- 13. On acceptance of the tender, the name of the accredited representative(s) of the contractor who would be responsible for taking instructions from the Engineer in charge shall be communicated to the Engineer in charge.
- 14-Special care should be taken to write the rates in figures as well as in words and the amounts in figures only, in such a way that interposition is not possible. The total amount should be written both in figures and words. The case of figures, the word Rs. should be written before rupees and word (P) after the decimal figures e.g. 2.15 p and case of words the word (Rupees) should proceed and the word 'only' it should in variably upto decimal places.
